#### Purpose, type of data and legal basis of the processing.

For the purposes of the research explained in the information sheet, the investigator will have to process some personal data and special categories of personal data, such as initials of name and surname, date of birth, gender, biological samples (saliva samples).

The mentioned data will be processed only for this research.

The legal basis for the processing is consent to the processing of personal data according to Article 6 c. 1 lett. A) of Reg. UE 2016/679. You can withdraw your consent to the processing of your personal data at any time by sending an email to <a href="mailto:dpo@unimi.it">dpo@unimi.it</a> or to the scientific contact person of the project. In this case, it will be impossible for her to continue participating in the research project.

#### Methods of processing and storage of personal data

The data collected will be processed in compliance with the principles of relevance, completeness and non-excessiveness in relation to the purposes for which they are processed, also with the aid of IT and telematic tools suitable for storing and managing the data, and, in any case, in such a way as to guarantee their security and protect the utmost confidentiality of the data subject.

The data will be stored in pseudo-anonymised form. In this case, the possibility of knowing the identity of the subject is reserved to the scientific contact person of the research.

The data will be stored for 5 years

Personal data will not be disseminated.

The data will not be transferred to third countries or international organizations

The data will be published in scientific journals, presented at conferences in anonymous and aggregated form.

The data will not be transferred to third parties either during or at the end of the research.

# **Exercising rights**
