

Ready-To-Go Project – Development and verification of a travel medical questionnaire

This project is organized by Prof. Dr. med. Jan Fehr, Head of the Department of Public and Global Health at the Epidemiology, Biostatistics and Prevention Institute (EBPI), University of Zurich.

Dear customer

We would like to ask you if you are interested in participating in our Ready-To-Go project described below.

1. Aim of the project

We have developed a travel medical questionnaire designed to assess travellers' risk of falling ill during their journey. We now want to verify the accuracy of this questionnaire and are therefore looking for volunteers who are willing to fill out the questionnaire.

2. Selection of participants

All Travel Clinic customers who are scheduled for a pre-travel health consultation can participate in our project. You must also be over 18 years of age and know either German or English.

3. General information about the project

The Ready-To-Go questionnaire is intended to be filled out by travellers before their trip to assess their risk of falling ill during their journey. The risk category resulting from the questionnaire will, in future, help travellers and medical professionals to decide if a pre-travel health consultation at a specialized Travel Clinic is necessary.

The Read-To-Go project is a project of the Department of Public & Global Health at the EBPI, University of Zurich. The recruitment of study participants takes place at the affiliated Travel Clinic.

This project will be carried out in accordance with Swiss law and has been reviewed and approved by the competent Ethics Committee.

4. Procedure

To verify the accuracy of this questionnaire we will ask all customers attending the Travel Clinic between November 2020 and January 2021 to participate in the Ready-To-Go project. If you are interested and agree to do so, you will be asked to fill out our questionnaire before you attend your pre-travel health consultation. This should take no longer than five minutes and you can proceed to your scheduled consultation.

5. Benefit

You will not benefit personally from participating in this project. However, your participation could result in the widespread use of the Ready-To-Go questionnaire.



6. Rights

Your participation in this project is voluntary. Should you decide not to participate or to withdraw your consent at a later point in time, you can do so without giving any specific reasons. Your pre-travel health consultation will not be affected in any way by your decision. You may at any stage ask questions about your participation in this project by contacting one of the contact persons listed below.

7. Duties

As a participant in the Ready-To-Go project, we ask you to fill out the entire questionnaire to the best of your knowledge. There are no other requirements.

8. Risks for participants

Participating in the project does not expose you to any health risks.

9. Results

The results of the Ready-To-Go project will be published in a travel medical journal. A link to the publication will be available on the official website of the EBPI once the project has been completed.

10. Data confidentiality

All the data collected for this project is completely anonymized. This means the data cannot be traced back to you. Your name will not appear in the Internet or in any of our publications. All the data collected for this project will be stored in a password-protected database. Project members with access to your data have to maintain confidentiality. This project complies with the data protection regulations. All participants have the right to view their data at any time.

Depending on the results of this study there might be follow-on studies to further evaluate the Ready-To-Go questionnaire. For this purpose we will note down your personal customer number which allows us to access your personal file at the Travel Clinic. We will ask you to sign a second declaration of consent (see below) to permit us to further use your data and to possibly contact you for follow-on studies. The participation in any follow-on studies is voluntary.

It is possible that this project will be reviewed by the competent Ethics Committee. The project leader may need to disclose your personal and medical information for such reviews in which case strict data confidentiality is maintained.

11. Withdrawal

You can withdraw from the project at any time. The data collected up to that point will still be included in the analyses of the project. Should you decide to withdraw from the project, we will delete your customer number from the project files. This means that nobody can find out that the data originated from you.

12. Compensation for participants

Participation in the project will not generate any costs for you or your health insurance, nor does it include any form of compensation for participants. Depending on the results this



project may lead to a commercialization of the Ready-To-Go questionnaire. Participation in the project does not entitle you to any commercial claims.

13. Liability

The institution responsible for this project is liable for any damage you might suffer as a result of your participation in the project. The conditions and the procedures are regulated by law.

14. Funding

This project is fully funded by the research fund of the University of Zurich.
