



Technology Enhanced integrated AsthMa care (TEAM care): a randomised control trial of technology to improve outcomes among children with asthma

Please help us learn whether new technologies can improve asthma care for children

Why have I received this?

We want to tell you about some exciting additions to children's asthma care in Lambeth, Southwark and Tower Hamlets. We are a team of researchers, doctors and nurses at King's College London, Guy's and St Thomas' Hospital, Queen Mary's University London and The Royal London Hospital who are working with the specialist asthma teams in your area to try and make the asthma care children receive even better. We are giving families the opportunity to take part in a research study that will see whether using new technologies, alongside usual asthma care, can help reduce the need for unplanned or emergency asthma treatment.

Before you and your child decide whether you would like to help us, it is important to understand why the project is being done and what it will involve.

What do I have to do?

You may have already received an invitation for your child to attend an appointment with an asthma nurse to make sure they are receiving the best possible care for their asthma. If you and your child decide to take part in this research study, we will ask you to sign a consent form when you attend this appointment, giving us permission to enroll your child in the research study. This will allow us to collect some information about your child's asthma using the health records completed when your child sees a specialist asthma nurse and also the records from GP appointments or hospital visits related to asthma care. Once this consent form is signed, we will at random allocate your child in to one of the three study groups. It will not be possible to choose which of the three groups your child is in so you need to be happy with any of the possible options below before you enrol your child in the research study.





Group 1

Children will receive exactly the same asthma care as those not taking part in the study.

This is called the Control
Group and is important as it
lets us compare
information from children
receiving the new
technologies to those not
receiving them.

Group 2

Your child will receive smart sensors that fit on to their usual inhalers.

This device is called a Propeller smart sensor



These sensors will record when the inhalers are used via an app on your phone.

It will remind you when your child should take their preventer inhaler each day.

The app also allows you to record the symptoms they experience, the reasons for using their reliever inhaler and any known triggers for those symptoms, like exercise or pollen.

Alongside these smart sensors your child will receive exactly the same asthma care given to all other children in the area.

It is easy to do but if you have any problems, we are here to help

Group 3

Your child will receive a small device to record wheeze sounds.

This device is called wheezo®



Each time the device is used (usually at a set time each day or when the reliever inhaler is needed), it records sounds and stores them on an app on your phone.

The app will tell you if wheeze is present and at what level of severity. You can use that, along with your child's asthma care plan, to decide if further action is needed.

Your child's asthma nurse or GP will also be able to listen to the recorded sounds at your appointment.

Alongside this wheeze recording device, your child will receive exactly the same asthma care given to all other children in the area.

Once your child is enrolled in the study and has been assigned a group, you will be given information on how to use the smart sensor or wheeze recording device if you are in one of the technology groups. Parents in these groups will be asked to register their child's details for the apps linked to the devices and start to use them at home. Our research nurses will be able to help you do that and the research team will be able to answer any questions you have once you are home and using the devices and apps.

For everyone taking part in the study, there will be a questionnaire to complete at enrolment, after 6 months and after 12 months of taking part. We will also ask you to answer a couple of questions each month about whether you have needed any unplanned appointments with your child's GP or at an emergency department for their asthma care. Your child's participation in the research study will end after 12 months and they will continue to receive the necessary care for their asthma from their GP and/or specialist asthma team. All other aspects of your child's asthma care during the 12 months you'll be taking part in the study, will be the same as it would be if you were not taking part.

We will also be carrying out some recorded group interviews to ask about participant's experiences of using the technologies. Not all participants will take part in these recorded interviews, and you will have the opportunity to receive more information and consent to this part of the trial at a later date. The audio recordings from these interviews will be transcribed by a company called 1st Class Transcription who have expertise in handling confidential data. Audio files will be destroyed at the end of the project while transcripts will be archived and kept for 25 years along with other data from this study, as is recommended for paediatric studies.

Do I or my child have to take part?

No, you and your child do not have to take part in this study if you do not wish to. However, taking part will help us to understand more about these new technologies and whether using them alongside the usual NHS service will improve patient care and asthma outcomes for children.

If I don't take part, would that affect the service my child is receiving?

No, the care your child is receiving will not be affected by your decision not to take part in this study. Your child will continue to receive any current and future services that might be available through their GP or local health care providers.

Would my child's GP be told that we are part of this project?

Yes, your child's GP will be sent a letter explaining your child's involvement in the study. If you have concerns about this, you can let us know.

Who will have access to my child's information?

Your child's information will be stored on a research database provided by our partners Health Touch Ltd. The research database will be password protected and only accessible to members of the research team at King's College London or the specialist nursing team providing your child's asthma care. We will keep your information confidential, safe and secure on our NHS and King's College London IRAS 311701 TEAM care Parent/Guardian Participant information sheet. computers that are password protected and at Health Touch Ltd on an encrypted database. Any information used for scientific reports will not have your child's name or any personal information on it. The clinical team will see your identifiable personal data but researchers at King's College London will see this data without any identifiable information. If you are in one of the technology groups, the companies administering the devices and associated Apps will have access to any information you provide via the App or website, including personal, identifiable information. This data will only be used with reference to the trial and not for any commercial purposes. Both the technology companies using tracking cookies to verify users. A link to each of their Privacy Statements is included on the following page.

One of the technologies, Propeller Health, is based in the United States of America. Whilst your child's data will be stored on servers within the European Union (EU), it is necessary for the operation of the Propeller mobile app, for personal data to be accessed by Propeller staff based in the United States of America. The United States of America has data protection laws that are different to the laws of the United Kingdom. However, King's College London and Propeller as its data processor are both subject to the UK General Data Protection Regulation and Data Protection Act 2018 and your child's personal data will be protected to these standards regardless of where it is processed by King's College London or its data processors.

Your child's information will not be shared with anyone else without your prior permission. Anonymous information collected for the research might be accessed by other members of Guy's and St Thomas's NHS Foundation Trust or King's College London for data auditing, regulatory inspection and or database maintaining. Data collected as part of this research will be safely archived for 25 years (this is the recommended length for children's studies) at King's College London after the end of the study.

After the study has finished, you will be emailed or posted the overall trial results or told how to access these online.

What do I need to do to get involved?

What happens if I change my mind?

If you or your child want to stop taking part at any point please contact us on [insert research phone number here]; data collected before you stop taking part will still be used as part of the project but we will not contact you about the project again in the future.





What are the benefits/disadvantages of taking part?

The information you provide will help us understand if our usual asthma care service can be improved by using technologies not currently part of the NHS service. If you and your child take part in this project, we will provide your family with a £10 voucher and pay reasonable travel expenses where appropriate.

We do not anticipate any disadvantages to taking part in this project. Any information we learn regarding your child's health will be reported back to your child's GP.

Who has reviewed this project?

This project has been developed by researchers at Kings College London University, Guy's and St Thomas' Hospital, Queen Mary's University London and The Royal London Hospital and reviewed by an NHS research ethics committee.

Concerns about this project?

If you have a concern about any aspect of this study, you should ask to speak to the researchers who will do their best to answer your questions [insert Principal Investigator name, telephone number and

e-mail address]. If you remain unhappy and wish to complain formally, you can do this through the Guy's and St Thomas' Patients Advice and Liaison Service (PALS) on 020 7188 8801, pals@gstt.nhs.uk. The PALS team are based in the main entrance on the ground floor at St Thomas' Hospital and on the ground floor at Guy's Hospital in the Tower Wing.

In the event that something does go wrong and you are harmed during the research you may have grounds for legal action for compensation against Guy's and St Thomas' NHS Foundation Trust and/or King's College London but you may have to pay your legal costs. The normal National Health Service complaints mechanisms will still be available to you (if appropriate).
