What is the purpose of this study?

We are interested in patients' views and experiences of GPs standing during consultations.

What are the possible benefits of taking part and why have I been chosen?

There are no expect benefits from taking part, but your responses will help us understand whether it is practical for GPs to stand when they see patients. You have been given this questionnaire because your GP was standing during your consultation today.

How do I take part and what would taking part in the upSTANDing GP Study involve?

The questionnaire will take a few minutes to complete. You are able to leave you contact details if you are interested in taking part in a follow-up interview. This is entirely voluntary.

Who is organising and funding the research?

This study is being organised and co-ordinated by Loughborough University. It is funded via the National Institute for Health Research – Research Academy. Will my taking part in this study be kept confidential?

What happens if I have a complaint about the study?
