INTERVIEWS - PREGNANT WOMEN

Please read this information sheet before you decide to take part. Please ask if there is anything that is not clear.

Why are we doing this research?

We are conducting this research as part of the MENJAGA study. This is a collaboration between Universitas Gadjah Mada, the London School of Hygiene and Tropical Medicine, United Kingdom, and the Kirby Institute University of New South Wales, Australia, which aims to eliminate newborn infection with HIV/syphilis/hepatitis B in Indonesia through improved detection and treatment in pregnant women.

Why have I been selected to take part in this study?

You have been invited to participate in this study because you have recently accessed antenatal care at one of the facilities involved in our research project.

What does this study involve?

If you choose to participate you will be asked questions on issues related to antenatal care during your pregnancy, your experiences of care, particularly in accessing HIV, syphilis and hepatitis B testing, and your perspectives on the quality of care provided to you.

What will happen if I agree to take part?

Members of our team will talk to you about the study and explain what taking part would mean for you. After you have had all your questions answered, you will be asked to sign a Consent Form, to confirm that you agree to take part.

We will sit down in a private place and ask you some questions in an **interview** which may last 45-60 minutes. We will ask you for permission to record the interview using an electronic recorder. A member from the research team will listen to this recording and write down what was said using a computer. We do this to make sure we have understood what people are telling us and to help us compare information from a variety of different people and locations. If you prefer not to be recorded, however, you can still participate in the

study and we will take extensive notes during the interview. The information you give us will only be seen by the researchers who are working on this project - and maybe some other researchers who are interested in what is happening in Indonesia. We will not show your answers to any healthcare providers or other people working in this area. We will not use your name so in future, no one will be able to know that it is you who told us this information.

Do I have to join the study?

No. It is completely up to you to decide if you want to take part in the study or if you would rather not. You can also choose to answer some questions but not others if they make you feel uncomfortable. Even if you do decide to join the study, you are free to stop the interview and withdraw at any time. Whether you answer our questions or not won't affect the care that you receive from the healthcare providers at this facility. We do not work for any health facility and will not be involved in your care in any way. Your decision to participate or not participate in the interview or to withdraw at any time will not affect your relationship with Universitas Gadjah Mada now or in the future.

What are the benefits of being involved in the study?

You may not benefit directly from being involved in the study, but your participation will provide valuable information for researchers, health staff and policy makers in Indonesia seeking to improve the care pregnant women, like yourself, receive.

Are there any risks involved in joining the study?

The interview will take up some of your time. We may ask some questions that you do not want to answer, but you can just tell us that and we will stop the interview or ask the next question. We do not think there are any other risks to you participating in this study because we will keep the answers you give us secret and only the researchers will know about it. When we write up the study, we will not use your name or the name of the health facility where we did the research.

Will my details and the information I give you be securely stored?

Yes. All information will be anonymised and securely stored at Universitas Gadjah Mada in Yogyakarta, Indonesia. You will NOT be identified in any reports or publications.

What will you do with the study findings?

After the study has been completed the results will be analysed. This can take up to 3-6 months. A plain language summary report in Indonesian and English will be produced and provided to people who took part in the study, community groups and key stakeholders. The results of the study will also be written up and submitted for publication in medical journals and may also be presented at national and international meetings and scientific conferences. We may use the information you provide during the interviews in the form of individual quotes in research reports or presentations. However, these will not contain any personal information that would make it possible for you to be identified.
