Localised mobile active case finding with Truenat molecular testing for the effective diagnosis of tuberculosis (LOCATE-TB) in Yogyakarta, Indonesia

Institutions involved: This research study is a part of a wider Tuberculosis Elimination program being conducted under the 'Zero TB Initiative Yogyakarta' (ZTBY), a collaborative program lead by the Universitas Gadjah Mada and Burnet Institute, in collaboration with the Yogyakarta government, Yogyakarta and Kulon Progo District Health Offices, the Yogyakarta Provincial Health Office and the Indonesian National TB program (NTP).

Telephone interview consent script for children 12-17 years old

Firstly, can I confirm that I am speaking to {{PARTICIPANT FIRST NAME AND LAST NAME}}. Can you tell me if you were recently screened for TB? And where were you screened?

You previously participated in our Truenat TB study when you were recently screened and tested for TB using the Truenat TB test at our active case finding service. We are studying whether the Truenat TB test is suitable for use in mobile case finding services and can make it faster for people to get their results. We are now asking if you will volunteer to take part in a phone interview as part of this research.

Are you interested in taking part in a phone interview for this study?

Before we interview you, I need to give you some information about the interview.

The interview will take approximately 30 minutes of your time and we will ask you about your experience with the TB case finding service using the Truenat TB test to help us understand whether how we are using the test is suitable for patients. Your responses will be anonymous – meaning that your name or other identifying information will not be used when analysing the data and reporting the results.

Would you like me to tell you more about who is doing this study?

The study is being conducted by the Zero TB Cities Project Yoygakarta. This project is led by the Universitas Gadjah Mada in Indonesia and the Burnet Institute from Australia.

If you choose to participate and give us permission to do so, we would like to record the interview. Would you like more information about how the recording will be made, stored and used?

We will record the interview on the phone that I am calling you on. At the end of the interview we will remove the recording from the phone and transfer it to secure storage and remove any identifying information. We will transcribe the interview (make a written copy of what was said in the interview) from the recording and then delete the recording. The transcribing will be done within six weeks of the interview and will be done by the study team or a company that provides professional and confidential transcribing services.

If you choose to withdraw from the study during the interview we will delete the recording and it will not be used in the study.

If you choose to participate, we can transfer phone credits for one hundred rupiah to your phone as thanks for giving up your time to be interviewed.

Your participation in this interview is completely voluntary. This means that you do not have to participate if you do not want to. You can ask me any questions you have about the study before deciding whether to participate.

If you agree to participate, you do not have to answer any questions that you do not wish to. You can also end the interview at any time without telling us the reason and, when ending the interview, you can instruct us not to use you answers in the study.

The ethical aspects of this research have been approved by the Medical Health Research Ethics Committee at the Universitas Gadjah Mada and The Alfred Hospital Ethics Committee (in Australia).
