Plain English summary of protocol

Background and study aims

The Incredible Years preschool course is for parents with children aged 3-5 years who have behavioural problems. It helps parents to adopt a positive approach incorporating praise, play, use of incentives, predictable routines, boundaries and strategies to manage challenging behaviour. Parents learn how to prepare their children for school, working more closely with early years professionals to develop emotional regulation and social skills. The aim of this study is to find out whether the Incredible Years Programme is effective for families.

Who can participate?

Parents/carers with children aged 0-5 years who have attended the Incredible Years Programme, Incredible Years trained practitioners/Family Support Workers, Incredible Years operational and project leads, and Local Authority commissioners

What does the study involve?

Parents/carers attend 14 weekly sessions of 2.5 hours duration with childcare provided in local children's centres. Incredible Years facilitators work with parents to improve emotional and social functioning and address, reduce and prevent aggression and behavioural problems. The course uses video clips depicting real life scenarios to encourage group discussion, problem solving and sharing of ideas and experiences. Parents receive manuals and group materials throughout the course in addition to home assignments. Interviews are also conducted with parents after the Programme to understand the extent to which they feel they have been helped. Incredible Years group facilitators, managers and local authority commissioners are interviewed regarding the implementation of Incredible Years.

What are the possible benefits and risks of participating?

Previous research suggests that Incredible Years helps parents to make positive changes in their

family relationships. The interviews allow participants to give their views on Incredible Years. There are no anticipated risks, but there is a protocol in place to signpost parents to additional support/advice if required, and the researcher is available afterwards for debriefing if necessary.

Interventions

The Incredible Years pre-school course is designed for families living in disadvantaged areas with children aged 3-5 years who are showing early onset behaviour problems. The programme consists of 14 weekly sessions of 2.5 hours duration with childcare provided. Incredible Years facilitators work with parents to improve emotional and social functioning and address, reduce and prevent aggression and behavioural problems. The course uses video clips depicting everyday scenarios to encourage group discussion, problem solving and sharing of ideas and experiences. Parents receive manuals and group materials throughout the course in addition to home assignments. Programme fidelity is maintained with a standardized training process involving peer review, videotape feedback and consultation.

The study design is a process and outcome evaluation using a mixed method approach. The process evaluation aims to understand how and why the intervention was adopted, drivers and barriers to implementation and the role of context. With respect to Incredible Years, this will involve semi-structured interviews with families, staff and stakeholders throughout the delivery of Incredible Years.

The outcome evaluation will measure the progress of families who attend the Incredible Years Programme. Pre and post Programme measures are: Children's behaviour (Strengths and Difficulties questionnaire); Emotional well-being (Adult well-being scale); Parenting skills (Parenting Daily Hassles scale); Parental self-efficacy (TOPSE tool).

Intervention Type

Measured pre and post Programme (14 weeks):

1. Children's behaviour, assessed using the Strengths and Difficulties questionnaire
2. Emotional well-being, assessed using the Adult well-being scale
3. Parenting skills, assessed using the Parenting Daily Hassles scale
4. Parental self-efficacy, assessed using the TOPSE tool
5. Parent attendance, monitored by facilitators over the 14 week duration of the course and reasons for absence noted where possible

Secondary outcome measures

1. Positive and negative aspects, ways they can improve, group dynamics, and group reactions /responses, reviewed by Group Facilitators after each session
2. Overall impressions of Incredible Years including changes observed in parents and any challenges identified, reviewed by Facilitators at the end of the Programme
3. Parental feedback, collected with an anonymous appraisal at the end of the Programme
