Interviews with patients, postal administration of questionnaire and exploratory trial with a small randomised controlled trial. For the RCT part, patients recruited to the telephone pare will be given a hospital card with the date and time when a trained specialist colorectal cancer nurse will call them. This will be compared to patients being seen at the hospital in the normal way.

3. Complete treatment for colorectal cancer
4. No evidence of local or regional recurrence
5. No current clinical problems
6. In addition for RCT stage: access to a telephone
