Plain English summary of protocol

Background and study aims

Health and employment are linked, with good employment having a positive impact on health, and health having a significant impact on a patient's ability to work. This is why the NHS is interested in the role it can play in supporting people back into employment. The aim of this study is to test whether employment support based in primary care services (for example, GP surgeries) can help people who are out of work and with a long-term health condition or disabilities to return to employment. This follows a well-established model of employment support called Individual Placement and Support. Individual Placement and Support has been shown to be very successful for people with severe mental health conditions. We wish to test if it is effective for a wider group of people with any long-term health condition or disability.

Who can participate?

People who live in Islington and Haringey who are out of work and with a long-term condition

What does the study involve?

Participants are randomly allocated into two groups. Participants in the control group receive business-as-usual employment support from the NHS. This is signposting to sources of external advice and guidance. Participants in the treatment group receive one-to-one employment coaching from an employment specialist based within the GP practice. The support is ongoing and continues once the participant has returned to employment. The employment support is entirely voluntary and participants can opt-out at any time. We then follow the participants' progress towards employment, and any changes in their health, for a period of up to one year.

What are the possible benefits and risks of participating?

Possible benefits include improved health and employment chances. We do not anticipate any risks above what would be expected in daily life.

Interventions

Patients randomly assigned to the control group will receive business as usual employment support from the NHS. This is signposting to sources of external advice and guidance.

Patients in the treatment group will receive one-to-one employment coaching from an employment specialist based within the GP practice. This follows a well-established model of employment support called Individual Placement and Support. The support is ongoing and continues once the person has returned to employment.

Primary outcome measure

The primary outcome measure is whether the person has returned to employment at 3, 6 and 12 months after starting the intervention. This will be collected by the patient reporting this to either the employment specialist (intervention group) or to a research assistant (control group).

Secondary outcome measures

Secondary outcome measures are to monitor changes to the patients health. These include three common questionnaires that measure: anxiety (GAD7), depression (PSQ9) and overall health status (EQ-5D). We will also measure indicators of being on the journey into employment, such as volunteering; and use of health services, such as attendances at GP surgeries. These will be collected 3, 6 and 12 months after the patient starts the intervention.

We will conduct subgroup analysis, for example of participants with higher levels of mental health difficulties, gender effects, and duration of unemployment.
